

MINTSCRAPS, INC. PRIVACY POLICY

This Privacy Policy (this “**Policy**”) explains how personal information is collected, used, and disclosed by **MintScraps, Inc.**, a Delaware corporation (“**MintScraps**”), and applies to consumer users (“**you**”) of MintScraps’ websites, applications, dashboards and other online services (collectively, the “**Sites**”).

Here at MintScraps, your privacy is important to us. This Policy is provided so that we may (1) better explain our privacy practices, and (2) inform you of your choices regarding the way your information is collected and used. The information addressed in this Policy refers to both personal and non-identifiable information. Personal information is information that is unique to you, and that may be used to identify you, such as your name or e-mail. Non-identifiable information is information that is only general information about your usage and profile, such as your location or gender.

This Policy applies only to information collected through our Sites. By using or accessing our Sites, you hereby warrant and represent that you have read, understand, and agree to all terms and conditions stated herein, in addition to our Terms of Service (“**Terms**”).

1. WHAT INFORMATION DO WE COLLECT?

We collect both personal and non-identifiable information that you provide us with both voluntarily and involuntarily. For example, though you may visit our site anonymously, to fully utilize our site we may obtain, or you may need to provide personal and non-identifiable information including but not limited to: your name, e-mail address, mailing address, phone number, IP address, location and GPS information, and credit card information.

Should you create an account or use the Sites, we will also collect any additional information you provide in personalizing your profile and account, such as employment and shift information, photos, ratings, comments, and postings that you submit to our site.

Any information we gather is for the purpose of customizing the MintScraps experience for our consumer, and in the aggregate, to analyze the waste stream data for tax and waste-related purposes, reports, and studies. In addition, any information or data entered by an employee of an enterprise customer is available to the main enterprise account. Your information is not shared or sold to any third parties, except as expressly provided for in this Policy and our Terms.

If you are given the option to access or register for the Sites through a third-party such as Facebook, you understand and authorize us to access and store associated information from the third-party, including but not limited to: your name, e-mail address, address, current city, profile picture URL, and recent locations.

2. WHAT DO WE DO WITH YOUR INFORMATION?

In general, the personal and non-identifiable information you provide is used to provide a better user experience for Sites and overall functionality.

Within that context, MintScraps uses information for the following purposes:

1. For billing, identification, authentication, and fraud prevention;
2. To analyze site usage and improve our services and Sites;
3. To deliver communications relevant to your usage of our services;
4. For internal market research, detecting criminal activity, and troubleshooting problems,
5. To enforce our Terms;
6. For distribution to any third parties who are bound by privacy restrictions at least as restrictive as set forth in this Policy, though you agree to hold harmless MintScraps from any claims or damages that may arise from the actions of any third parties;
7. To conduct research about our services;
8. To personalize your experience;
9. To investigate complaints or abuse notices;
10. To provide promotional or targeted offers;
11. To perform market research for marketing and advertising purposes;
12. To help develop new services and customize content;
13. To improve customer service;
14. To generate estimates related to waste and deductions;
15. To conduct analytics based on waste and waste reduction.

In that case that the Sites process payments and purchases, we will use financial information solely as authorized by you in accordance with the service.

3. HOW DO WE PROTECT YOUR INFORMATION?

MintScraps takes the protection of your personal and non-identifiable information seriously, and we have put into place appropriate safeguards to secure the information.

We also maintain a variety of security measures to maintain the safety of your personal information enter, submit, or access your personal information. After a transaction, your private information will not be stored on our servers, and is always transmitted in encrypted form.

Unfortunately, no data transmission over the Internet can be characterized as 100% secure. While MintScraps uses all commercially reasonable efforts to ensure information security, MintScraps cannot guarantee the security of any information you choose to provide to us, and you do so at your own risk.

We expressly disclaim any liability should any other individuals obtain the information you submitted to us. For any unauthorized access to or use of our secure servers or any personal and financial information stored therein, you agree to hold MintScraps harmless for any damages that may result therefrom.

In the event that personal information is compromised as a result of a breach of security, we will promptly notify those persons whose personal information has been compromised.

4. DO WE DISCLOSE ANY INFORMATION TO OUTSIDE PARTIES?

No. We generally do not sell, trade, or otherwise transfer your personal information to outside parties, except to the enterprise customer if you enter information as an employee, and to analyze waste usage patterns with third parties. However, this does not include a transfer to trusted third parties who assist us in operating our site, conducting our business, or servicing you, as long as those parties similarly agree to keep this information confidential. These may also include third parties with whom we have a promotional relationship.

We reserve the right to disclose personal information at our discretion if required by law, or if we are given reason to believe, in our sole discretion, that someone is causing injury to or interference with the rights of users, the general public, or MintScraps, to comply with a judicial proceeding, court order or legal process.

We reserve the right to transfer, sell and/or distribute all information collected through our services to an affiliate, subsidiary, or third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or part of our business, assets or stock. We will use our best efforts to ensure that the new entity follows this Policy with respect to your Personal Information, as and to the extent required by applicable law.

We reserve the right to provide your non-identifiable information to third parties to help us improve our services.

We may disclose your information if required to do so by law or in the good faith belief that disclosure is necessary to: (1) satisfy legal obligations or comply with legal process (such as a subpoena) served on MintScraps; (2) protect MintScraps and others from fraudulent, abusive, predatory, or unlawful uses or activity; (3) investigate and defend MintScraps against any legal claims or threats; (4) protect and defend the rights or property of MintScraps; (5) take action relating to user complaints, or (6) act in urgent circumstances to protect (a) the personal safety of users of MintScraps, (b) our services and policies, (c) or the public.

You may also decline to share certain information with us, in which case we may not be able to provide to you some of the features and functionality found on our services. Please note that while your changes are reflected promptly in active user databases, we may retain all information you submit for a variety of purposes, including backups and archiving, prevention of fraud and abuse, and analytics. You may also modify the cookie and location sharing settings on your device or in your web browser to limit the information you share.

You are responsible for maintaining the secrecy of your unique password and account information at all times. Please be careful with this information.

5. COOKIES AND OTHER TECHNOLOGIES

MintScraps may utilize cookies, which are files that remain on your computer in order to track and remember certain behavior and personal information. They would be used to help remember your preferences, habits, and previous behavior. In addition, to compile aggregate data about site traffic and site interaction so we can enhance your user experience in the future. We may contract with third-party service providers to assist us in better understanding our site visitors. These service providers would not be permitted to use the information collected on our behalf except to help us conduct and improve our business.

If you disable cookies, some aspects of MintScraps may not work properly, and you may not be able to use our services.

We may also enable third-party advertising networks, advertisers and ad servers to promote third-party products and/or services by placing advertisements on MintScraps. These advertisers and ad servers may use their own cookies and/or “web beacons.” Clicking on such advertisements will direct you to the website of a third-party and the advertiser, for which this Policy does not cover.

MintScraps and/or other third parties may collect your IP address, which is a number assigned to your computer. These are used to monitor geographic traffic for users and combat fraud.

Other types of information collected via cookies or other technologies include, but are not limited to: browser type, operating system, mobile identification number, GPS and geographic location, and browsing habits.

6. THIRD PARTY LINKS

At our discretion, we may include or offer third party products or services on our site. Additionally, some of the services or materials included, accessible, or linked through our services may be delivered through third parties, who may in turn use technologies to track information about your usage and patterns.

These third party sites have separate and independent privacy policies, therefore we have no responsibility or liability for the personal information provided to these linked sites. Additionally, we do not have access or control over third-party usage of information or tracking technologies.

7. CHILD PROTECTION

We are in compliance with the requirements of COPPA (Childrens Online Privacy Protection Act), and we do not collect any information from anyone under 13 years of age. Our website, products and services are all directed to people who are at least 13 years old or older. If we obtain actual knowledge that a user is under 13, we will take steps to remove that user’s personal information from our databases.

If you are a parent or guardian and discover that your child under the age of 13 has obtained a MintScraps account, then you may alert us and request that we delete the child’s personal information.

8. CONTROLLING YOUR PERSONAL INFORMATION

You can access and edit your personal information by logging into your account and finding the “Edit Account” or equivalent function. To protect your privacy and security, we will also take reasonable steps to verify your identity before granting access or making edits. The main form of identity management is your e-mail address. Please always use a valid and up-to-date e-mail address.

You may also contact us to request deletion of your personal information, which will result in deletion from the activate database, but may remain in our storage archives.

9. MODIFICATIONS TO OUR POLICY

This Policy is subject to revision at our discretion as necessary. If we make any material changes in the way your personal information is collected, used or disseminated, we will post an alert on this page, and/or update the modification date below, and/or notify you of these changes by e-mail.

Continued use of MintScraps indicates your acknowledgement of such changes and agreement to be bound by the terms and conditions of such changes.
